TENDER FOR THE ALLOCATION OF BEDS TO UNIVERSITY STUDENTS IN THE RESIDENCES 'CAMPUSX' – ACADEMIC YEAR 2024-2025

The Fondazione eXperience (hereafter '**Foundation**'), which is a partner of Campus X. s.r.l (hereafter, '**Manager**') – one of the leading players in Italy's student housing industry –, aims at spreading scientific culture and knowledge all over the national territory, by promoting and supporting initiatives for the training of university students, PhD students, researchers, professors, and attendees of Italian and foreign specialisation courses, masters, university schools and post-graduate training schools recognized by it, as well as by fostering and giving value to the skills acquired by students during their academic career and in their personal, cultural and professional development, with the aim of contributing to the training of future managers for the management of public and private companies and institutions. Moreover, in order to achieve the abovementioned objectives, the Foundation promotes, organizes and manages services aimed at supporting and helping young students.

The Foundation hereby announces a selection (hereafter, '**Tender**') for the allocation of beds (hereafter, '**Beds**') to university students only, created through specific interventions under the National Recovery and Resilience Plan (NRRP) - Mission 4 - Component 1 - Reform 1.7 'Student Housing and Reform of Student Housing Legislation' promoted by the Manager and financed through NRRP funds. The Beds are located in the following residences managed by the Manager:

1. 'CX Bari', located in Bari, via G. Amendola 184 (hereafter, '**CXBA**'), for a total of 393 Beds;
2. 'CX Firenze', located in Florence, viale G.B. Morgagni 51 (hereafter, '**CXFI**'), for a total of 188 Beds;
3. 'CX Roma', located in Rome, via di Passolombardo 341 (hereafter, '**CXRM**'), for a total of 400 Beds;

4. 'CX Torino', located in Turin, via Belfiore 23 (hereafter, '**CXTO**'), for a total of 198 Beds;
5. 'CX Milano', located in Milan, via Suzzani 96/98 (hereafter, '**CXMI**'), for a total of 549 Beds (all together, CXBA, CXFI, CXRM, CXTO and CXMI are defined '**Residences**').

ARTICLE 1

SPACES AND SERVICES

1.1. For the purposes of this tender, the Manager hereby makes available a total of 1,728 Beds, divided as indicated in Article 1.2 below, arranged in different kinds of rooms, in addition to several communal spaces designed to encourage study and community life. Specifically, each Residence consists of:

1.1.2. CXBA

- 'Studio Plus' rooms, with one bed, private bathroom, refrigerator and kitchenette;
- 'Large Studio Plus' rooms, with two beds, private bathroom, refrigerator and kitchenette;

 - 'Prime Large Studio' rooms, with two beds, private bathroom, television and large kitchen;

the kitchen are shared with another room only;

in addition to shared kitchens, study rooms, washing room, recreational rooms, gym, bar, outside areas, car parking (both inside and outside) and bicycle parking.

1.1.4. CXRM

- 'Co-Living' rooms, with one bed. The private bathroom and the kitchen are shared with another room only;

- 'Large Co-Living' rooms, with one bed. The private bathroom and the kitchen are shared with another room only;

- 'Studio Plus' rooms, with one bed, private bathroom, refrigerator and kitchenette;

in addition to study rooms, washing room, recreational rooms, auditorium, gym, bar, restaurant, outdoor sports centre, car, motorcycle and moped parking as well as bicycle parking.

1.1.5. CXTO

- 'Studio' rooms, which are 15 sq m big, with one bed, private bathroom, refrigerator and television;

- 'Large Studio' rooms, that is a double room with one bed only, private bathroom, refrigerator and television;

- 'Co-Living' rooms, with one bed and television. The private bathroom and the kitchen are shared with three more rooms;

- 'Large Co-Living' rooms, with one bed and television. The private bathroom and the kitchen are shared with three more rooms;

in addition to shared kitchens, study rooms, washing room, recreational rooms, gym, bar, restaurant, and indoor car parking.

1.1.6. CXMI

- 'Duplex Studio' rooms, with one bed, private bathroom, refrigerator, television and mezzanine floor;

- 'Studio Plus' rooms, with double bed, private bathroom, refrigerator and television;

- 'Large Studio Plus' rooms, with two beds, private bathroom, refrigerator, television and kitchenette;

- 'Prime Duplex Studio' rooms, with double bed, private bathroom, refrigerator, television, kitchenette and mezzanine floor;

in addition to shared kitchens, study rooms, washing room, recreational rooms, gym, bar, restaurant and bicycle parking.

1.1.7. The 1,728 Beds covered by the Tender are divided as follows:

(a) 393 Beds at CXBA;

(b) 188 Beds at CXFI;

(c) 400 Beds at CXRM;

(d) 198 Beds at CXTO;

(e) 549 Beds at CXMI.

1.2. Beds shall be allocated to Italian students based on merit, according to the requirements set out in Article 3.2 below, as well as to international students.

1.3. Inside each of the Residences, the following additional services, which are included in the fees, will be provided:

(i) daily cleaning of communal spaces;

(ii) WiFi connection;

(iii) heating;

(iv) concierge and security;

(v) gym;

(vi) reception.

ARTICLE 2

FEES

For each of the Residences, the Manager shall apply the monthly fees indicated in Annex under [lett. A](#), except for any amendment whatsoever as governed by the contract signed by the beneficiaries.

ARTICLE 3

ADMISSION REQUIREMENTS

3.1. All the Italian and international students enrolled in any University or University-level institution whatsoever, including higher institutes of artistic, music and choreographic training (hereafter, '**Applicants**'), with the exception of distance learning universities, may participate in the tender for the allocation of Beds. Applicants are divided as follows: (i) Applicants who in the academic year 2023-2024 were Beneficiaries (as defined below) of a Bed in one of the Residences and who renew their application for the allocation of a Bed in the same Residence (hereafter, '**Renewal Students**'), and (ii) Applicants who apply for the allocation of a Bed for the first time ever or who apply for a different Residence from the previous academic year (hereafter, '**New Students**').

3.2. Applicants shall meet the following requirements:

(a) being enrolled in a degree course in (i) legally recognised state and non-state universities, with the exception of distance learning universities, (ii) higher institutes of music and choreographic studies, or (iii) institutes of artistic and music training and specialisation;

(b) having no criminal record and no pending charges;

(c) being immune to diseases compatible with community life.

3.3. In addition to meeting the requirements set out in Article 3.2 above, Renewal Students shall also comply with the following requirements:

(a) not having been in breach of the 'General Rules and Regulations' in force

at the Residences;

(b) being up to date with the payment of the amounts provided for by the contract at the time of submission of the application.

3.4. The requirements referred to in Art. 3.2 above shall be self-certified at the time of submission of the application and shall remain in force for the entire period of time the Bed is used, under penalty of revocation of the allocation, as provided for by Art. 7 below.

3.5. In view of the specific nature of university students' accommodation, which strictly depends on the academic activities carried out throughout the year, and in order to avoid partial occupation of the Residences, thus safeguarding the purposes set out in the NRRP, Applicants who indicate a stay of more than 12 months in one of the Residences in their application will be given priority in the allocation of the Beds.

ARTICLE 4

ARTICLE 5

RANKING LISTS

5.1. Provided that they fulfil the requirements set out in Article 3.2 and/or 3.3, as the case may be, Renewal Students shall have priority in the allocation of Beds over New Students.

5.2. The Foundation or the Manager acting on behalf of it shall inform each successful Applicant of the provisional allocation of the Bed by e-mail as soon as possible.

(A) New Students

5.3.A. The provisional beneficiaries of the Beds shall be the New Students with the highest score, who meet the requirements set out in Article 3.2. For this purpose, the following scores shall be awarded:

(a) if they are enrolled in years subsequent to the first year of a degree course, a score of between 0 and 30 will be awarded based on the grade point average self-certified in the application;

(b) if they are enrolled in the first year of a degree course, a score of between 0 and 30 will be awarded based on the grade of the final State exam or equivalent in hundredths, as self-certified in the application;

(c) if they are enrolled in the first year of a masters' degree course, a score of between 0 and 30 will be awarded based on the graduation grade, as self-certified in the application;

(d) if they are not Italian nationals and they are enrolled in the first year of a degree course, a score of between 0 and 30 will be awarded based on their certified level of knowledge of Italian or a language other than their mother tongue.

In the event that the self-certifications referred to above are not submitted, they shall not be given any score points.

5.4.A. In the event of a tied score, priority shall be given to the younger New Student. If a tie score persists, priority shall be given to the New Student with the earliest application date.

(B) Renewal Students

5.5.B. The provisional beneficiaries of the Beds shall be the Renewal Students with the highest score, who meet the requirements set out in Article 3.2 and 3.3. For this purpose, the following scores shall be awarded:

(a) if they are enrolled in years subsequent to the first year of a degree course, a score of between 0 and 30 will be awarded based on the grade point average self-certified in the application;

(b) if they are enrolled in the first year of a degree course, a score of between 0 and 30 will be awarded based on the grade of the final State exam or equivalent in hundredths, as self-certified in the application;

(d) if they are not Italian nationals and they are enrolled in the first year of a degree course, a score of between 0 and 30 will be awarded based on their certified level of knowledge of Italian or a language other than their mother tongue.

In the event that the self-certifications referred to above are not submitted, they shall not be given any score points.

5.5.B. In the event of a tied score, priority shall be given to the younger Renewal Student. If a tie score persists, priority shall be given to the Renewal Student with the earliest application date.

ARTICLE 6

ACCEPTANCE AND ALLOCATION OF BEDS

6.1. Successful New Students shall be contacted by the Foundation or Manager acting on behalf of it in order to complete the procedure for the allocation of Beds. For this purpose, in addition to the notice of acceptance of the Bed to be sent in the ways that will be indicated, successful New Students shall submit within 3 working days - under penalty of forfeiture of the assignment - the documentation proving the payment, by way of security deposit, of the amount (which varies depending on the residence chosen) that will be communicated by the Foundation or the Manager acting on behalf of it, it being understood that in the event of failure to take over the Bed, the Manager will keep the abovementioned deposit.

6.2. Successful Renewal Students shall be contacted by the Foundation or Manager acting on behalf of it in order to complete the procedure for the allocation of Beds. For this purpose, successful Renewal Students shall submit, within the term indicated by the Foundation or Manager acting on behalf of it, and under penalty of forfeiture of the assignment, the notice of acceptance of the Bed to be sent in the ways that will be indicated.

6.3. Once the documentation under Articles 6.1 and 6.2, including the documents certifying the payment of the amount set forth in Article 6.1 above, is

successfully verified, the Foundation shall confirm the allocation of the Beds by informing each of the successful Applicants (**'Beneficiary'**) by email, also through the Manager. On that occasion, the period of time within which Beds shall be taken over will be communicated. In the event that the above deadline is not met or a Beneficiary refuses – in writing – to be assigned their Bed, the Foundation, without prejudice to Article 6.1. above, may move on to the next Applicants on the ranking lists and shortlist a new successful Applicant.

ARTICLE 7

ALLOCATION OF BEDS AFTER THE DEADLINE FOR SUBMITTING APPLICATIONS

7.1. Following the deadline referred to in Articles 4.1.A and 4.1.B, in order to accommodate as many students as possible, the allocation of any Beds that may still be available will take place on a first-come-first-served basis.

7.2. This is without prejudice to the requirements and conditions for the allocation of Beds referred to in Art. 3. Allocations shall be made according to the procedures set forth in Articles 5.2, 5.3.

ARTICLE 8

RELATIONSHIP BETWEEN THE MANAGER AND BENEFICIARIES

The relationship between the Manager and Beneficiaries shall be regulated by specific agreements to be signed by Beneficiaries before they take over their Bed.

ARTICLE 9

VERIFICATION OF THE TRUTHFULNESS OF THE DECLARATIONS. REVOCATION OF ASSIGNED BEDS.

9.1. The Foundation reserves the right henceforth to carry out rigorous checks on the declarations made and documentation provided by the Applicants
